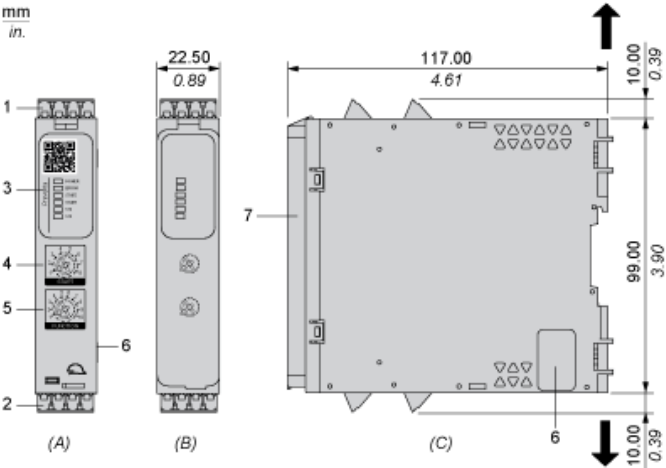

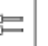

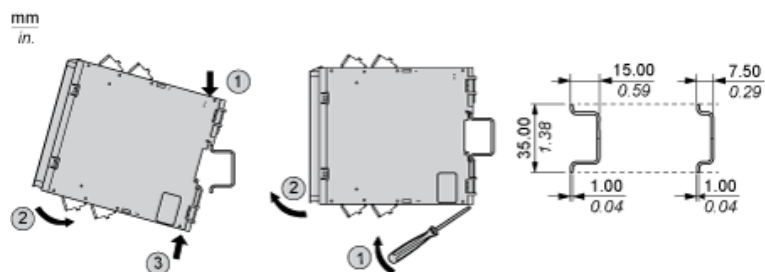
Front and Side Views



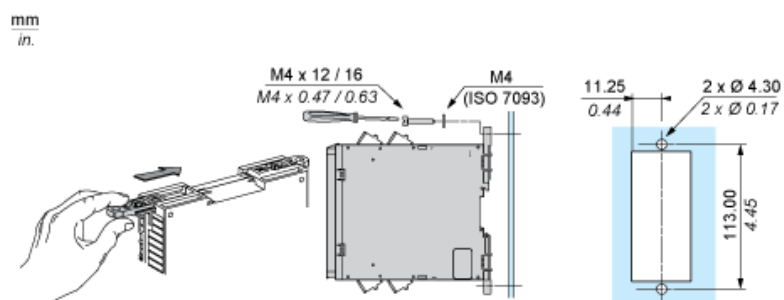
- (A) : Product drawing

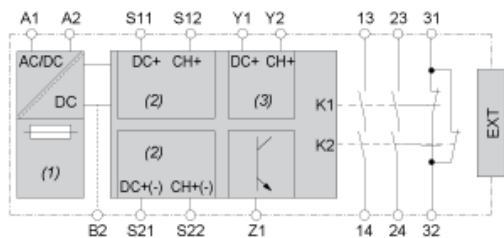
